**SUMMARY:** This position provides essential support to the Boys & Girls Club program, in coordinating and delivering youth sports, cultural and recreation activities for the youth. The overall goal is to provide activities and services that prepare youth for success and creates an outcome-driven Club experience that facilitates achievement of youth development outcomes.

**ESSENTIAL DUTIES AND RESPONSIBILITIES** include the following:: Because of the Tribe's commitment to community service and the well-being of its members, each employee may be expected to perform a wide range of office and field duties from time to time. Such duties may or may not be related to their regular responsibilities.

Assists in team planning, coordination, and delivery of year-round age-appropriate activities for youth ages 5-18 years old such as youth sports, recreation, and cultural activities in the Makah community.

Follows daily, weekly, and monthly Club schedules. Coordinates with volunteers, instructors, coaches, educators, and others in delivery of various services. Monitors assigned events, services, and ensures that activities are properly supervised, materials, and adult/supervisors are sufficient, any program funds are accounted for, and that facilities are maintained and secured for each activity.

Track and collect sign in entry forms for youth and adults, collects and maintains monthly data reports; assist in preparing weekly summaries of volunteer hours, rates, services, and supplies donated for activities to be submitted in monthly report.

Assist in ordering and maintaining program supplies, equipment, inventory, activity logs, and maintains report of equipment theft, loss, or vandalism.

Assist in the training of youth and adult volunteers with daily Club activities and on recreation, culture, or sports activities, program procedures and completion of activity and equipment logs.

Participates in training on youth sports programs and services, record keeping and data collection, workshops/conferences as assigned. Travel required for youth activities and events, as well as some training.

**QUALIFICATION REQUIREMENTS:**

**EDUCATION and/or EXPERIENCE:**

High school diploma or general education degree (GED).

**LANGUAGE SKILLS:**

Ability to read, analyze, and interpret professional journals, technical procedures of governmental regulations. Ability to write reports, and business correspondence. Ability to effectively present information and report to questions from groups of clients, and the general public.

**MATHEMATICAL SKILLS:**

Ability to add, subtract, multiply and divide in all units of measure, using whole numbers, common fractions, and decimals.

**REASONING ABILITY:**

Ability to define problems, collect data, establish facts, and draw valid conclusions. Ability to interpret a variety of instructions furnished in written, oral, diagram, or schedule form.

**CERTIFICATES, LICENSES, REGISTRATIONS:**

Must have a valid Washington State Drivers license and insurable. May be required to drive a Tribal GSA vehicle to perform job duties. If so, a driving history/background will be conducted on the applicant.

This position is classified as a sensitive Tribal position; therefore, applicant must authorize a background investigation in order to be considered for an interview.

**OTHER SKILLS AND ABILITIES:**

Ability to establish and maintain effective working relationships with staff, private agencies, and the general public.

Ability to communicate effectively, orally and in writing, with demonstrated ability to conduct presentations to small groups.

Ability to relate well with a diverse group of people, including staff, the public, professional agencies, and organizations.

Ability to operate effectively in crisis and or emergency situation.

Ability to operate a computer with knowledge of various software programs.

Ability to maintain confidentiality of records and information pertinent to the nature of work.

Knowledge of HIPAA (Health Insurance Portability and Accountability Act) and the use of confidential information and health records as an integral part of the interviewing office function and the privacy of individuals which must be protected to the fullest extent possible.

Must submit to and clear a pre-employment alcohol and drug test and random testing, in accordance with the Drug and Alcohol-Free Workplace Act of 2002.

### **PHYSICAL DEMANDS**

While performing the duties of this job, the employee is occasionally required to stand, walk, and sit. The employee must occasionally lift and/or move up to 50 pounds.
