Announcement: Request for Bids for Site Work

Time Frame: To be completed on or before June 29th, 2025

Bid Amount: Bids of \$5,000 or less are preferred, but reasonable bids that include justification for bid above that amount may be considered; bids over \$10,000 will not be considered.

The Contractor is being hired to do site work to clear vegetation and complete a gravel pad at the Makah Tribal Center. The Contractor shall complete the following:

1. Clear and remove all vegetation in the area (approx. 480 sq. ft, 0.011 acres) specified by the Contract Representative (indicated by the white rectangle on the map attached below)
2. Construct a level gravel pad for placement of plastic storage sheds
 - Pad should measure approximately 40 ft long by 12 ft wide by ~12-18 inches depth (est. max 26.67 cubic yards of material)
 - Gravel/rock for building pad should be 5/8 minus, or similar, and be compacted with additional fines if needed
 - Pad area should be uniformly compacted and level
3. Optional: Bidders with forklift capacity able to move ~8 ft x 8ft Rubbermaid sheds may include a separate line showing the cost to move four (4) Rubbermaid sheds to the gravel pad area (locations to be specified by Contract Representative). Please clearly indicate the cost for this separate from tasks 1 and 2 above.

Bid submission must include:

- Full name
- Permanent mailing address
- Social Security Number
- Phone number and e-mail
- Description of experience/qualifications
- Bid amount, separate amount if including shed moving, estimated project completion date

NOTE: TERO and other Tribal Requirements may apply

Figure 1. For Request for Bids for Site Work, bids due June 18th, 2025 at 12:00 PM. Fisheries work area is located on the Makah Tribal Center adjacent to the Fisheries boat garage and the old Realty Building. Contractor will clear vegetation and build a gravel pad next to the conex box visible in this image in the area indicated by the white outlined rectangle. Approximate measurements for this area are 40 ft long (lengthwise along the conex) and 12 ft wide (to the edge of the boat garage). Gravel/fill will be approximately 12–18 inches deep to build the pad up to the height of the current pad underneath the conex box. Pad should be leveled for placement of storage sheds. Optional: Bidders with forklift capacity can include in the bid the cost to move the storage sheds.
