<u>Renovation of the Animal Control Building – must include all materials, construction and installation.</u>

- 1. 7 Windows removal of old windows or window frames and install of new window, 2 new doors installed
- 2. New Roof
- 3. Remove trash out of the building
- 4. Cut brush down outside the building
- 5. Lighting inside and outside= electrical may need to be updated.
